### Ground Rules:

- Bell Collar Catch Only
- Ropes will be tied to the saddle horn with nylon string. (no unraveling of string)
- A knot must be at the end of the rope with the string tied at the knot, there will be no tail.
- A barrier will be a 10-second penalty
- **No one will be allowed to hold the head of the calf back in the chute.**
- A 60-second time limit will be enforced in the box. The clock will start when the prior animal leaves the arena and the arena is suitable to compete. It will stop if the animal is not cooperating but will start immediately once the animal is cooperating again. At the time limit the calf will be let out of the chute.
- WPRA Dress Code will be enforced.
- Draw Outs must be done by the online entry deadline. (Medical and Vet Release accepted till the time of roping starts)
- Flogger & Line Judge has the final call.

**If any of these ground rules are broken it will result in disqualification.**

### STATEMENT AND RELEASE:

PARTICIPANT'S RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY  
AGREEMENT FOR THE KARI BURNS MEMORIAL, LLC, ROPING  
DBA "WORLD'S RICHEST BREAKAWAY"

**BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING OF AND AGREEMENT TO ITS TERMS.**

This is an agreement between the Undersigned (or minor in my charge) and the Kari Burns Memorial, LLC, roping event (dba as "World's Richest Breakaway") and all volunteers, agents, employees and related entities of the event (the "Producer").

I, \_\_\_\_\_ (hereinafter the "Undersigned") on behalf of myself, my personal representatives, heirs, next-of-kin, spouse and assigns HEREBY:

1. Acknowledge that horseback riding and breakaway roping is a dangerous activity and involves RISKS that may cause SERIOUS INJURY AND IN SOME CASES DEATH to humans and/or animals because of the unpredictable nature of horses and cattle, regardless of their training and past performance. I also understand per Montana Code Annotated 27-1-725 and related statutes that an equine facility/professional is not liable for any injuries I may incur by participation in an equine sport.
2. Knowing these facts, I voluntarily assume the risk of injury and/or death to myself and any equine animal in my care or ownership that is on premises and acknowledge that risk is inherent in horseback riding and roping activities. I hereby **RELEASE, DISCHARGE AND PROMISE NOT TO SUE** the Producer, doing business under its own name or any other name and/or any of its owners, officers, employees, agents or volunteers (hereinafter the "Releasees"), for any loss, liability, property damage, injury, death or cost whatsoever arising out of or related to any loss, liability, property damage, injury, death or cost to my person or property (which includes equines) that may occur as a Participant in the "World's Richest Breakaway."
3. Agree to Release the Releasees' from any claim whatsoever, including that such Releasees' are or may be negligent in connection with my riding or roping experience and I understand that no guarantees of any kind are made as to the fitness and safety of the equipment and facility used by the Releasee/Producer or as to the experience and training of the volunteers and staff running the roping and I expressly waive bringing any cause of action that may arise from faulty equipment or facilities, including injury, death or property damage.
4. IDEMNIFY, AND SAVE AND HOLD HARMLESS, the Producer from and against any claim, loss, liability, damage, injury or cost that may arise out of or in any way is connected to my participation in this event, my use of a horse and rope, and any equipment or facilities provided by the Producer or any acts or omissions of Producer.
5. Agree to abide by and follow any instructions given or rules established by the Producer with regard to my participation in this event, use of a horse and rope, or any equipment or gear provided therewith.
6. I, the Undersigned, expressly agree that this release and waiver of liability, assumption of risk, and indemnity agreement is governed by the State of Montana and is intended to be as broad and inclusive as is permitted by Montana law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
7. Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Producer, its owners, agents, employees or volunteers, the Undersigned will pay all attorney's fees and costs incurred by the Producer in defending such an action in the event a court or other legal body determines that I, the Undersigned, breached this Contract. For all other causes of actions that may be brought the Undersigned agrees she will pay all attorneys' fees of Producer incurred in defending itself if such cause fails or is deemed to be without merit.
