Ground Rules:

- Bell Collar Catch Only
- Ropes will be tied to saddle horn with nylon string. (no unraveling of string)
- A knot must be at the end of the rope with the string tied at the knot, there will be no tail.
- Barrier will be 10 second penalty
- **No one will be allowed to hold the head of calf back in the chute.**
- A 60-second time limit will be enforced in the box. The clock will start when the prior animal leaves the arena and the arena is suitable to compete. It will stop if animal is not cooperating but will start immediately once the animal is cooperating again. At the time limit the calf will be let out of the chute.
- WPRA Dress Code will be enforced.
- Draw Outs must be done by online entry deadline. (Medical and Vet Release accepted till time of roping starts)
- Flagger & Line Judge has final call.
- Must enter World's Richest Breakaway to enter RFD-TV's The American Side Pot.

If any of these ground rules are broken it will result with a disqualification.
